PRIOR TO THE CONCLUSION OF THE HEARING, THE GOVERNING BODY OF THE TAXING AUTHORITY SHALL AMEND THE TENTATIVE BUDGET, RE-COMPUTE ITS PROPOSED MILLAGE RATE, AND PUBLICLY ANNOUNCE THE PERCENT, IF ANY, BY WHICH THE RE-COMPUTED PROPOSED MILLAGE RATE EXCEEDS THE ROLLED-BACK RATE. THAT PERCENT SHALL BE CHARACTERIZED AS THE PERCENTAGE INCREASE IN PROPERTY TAXES TENTATIVELY ADOPTED BY THE GOVERNING BODY.
