Mayor La Paz: March 14th attended a meeting hosted the federal Economic Development Administration. Agencies represented were the Federal EDA, Army Corps of Engineers, USDA, FL DEO, Region 4 Environmental Protection Agency, & Gulf Coast Career Source. Representatives wanted to know our needs in Franklin County and to explain what programs are available for Hurricane impacted communities.

March 15th the Florida Trustee Implementation Group announced this year's NRDA grant recipients which include Phase II of Carrabelle's Lighthouse Estates Septic Tank Abatement project \$3,237,986. This NRDA grant will fund septic to

sewer for 110 residences in addition to the fully executed grant from the WMD in the amount of \$851,000 for the Phase I septic to sewer project to 53 residences. The W&S dept now has full funding for septic tank abatement and sewer extension to a total of 163 residences. The 2 combined grants amount to \$4,088,986.00.

Joe Crozier, ARPC Regional Planner, has re-submitted a grant application for the City to the DEP for development of a McKissack Beach management plan. Mr. Crozier reported the DEP folks say it is favorable the grant will award up to \$75K to include conflict facilitators. If awarded, the ARPC will manage all grant documents, deliverables, and required workshops. The finished product will be a guiding document and not a regulatory document.

On March 21st, Courtney, Keisha, and I met with Christopher Shear of McDowell Housing Partners of Miami who recently purchased the defunct Jordan Bayou Preserve PUD subdivision located off Airport Road and in the City Limits. Mr. Shear reviewed information regarding building permits, codes, flood zones, setbacks, as-built plans, infrastructure, and ordinances. McDowell Housing plans to construct affordable single-family workforce housing. They are applying for a soft loan from the State designated for development of workforce housing, SHIP funds, and home loan programs. The loan program caveats include that housing units must be rental units for the first 15 years. The subdivision will have covenants, a clubhouse, and possibly a pool. The units will range in size from 1,200 to 1,300 sq. ft. 10 units will rent for \$586 monthly and 40 units will rent for \$784 monthly. McDowell Housing plans to have construction underway this fall, are still deciding on stick-built vs modular. The entire subdivision will be built out at one time. There will be no spec homes. We discussed low income housing vs affordable workforce housing, tax development qualifiers, and we were assured that tax credits would not be involved with this development. We discussed the old City Hall building and how the building could be converted to senior living apartments. Mr. Shear will plan a return visit to tour the old school site. Requested "no littering" signage posted along the Marine St Boardwalk next to the Tom Crum Fish House and request police department to patrol the area and issue citations for littering in the street and throwing items over the boardwalk onto private property.

The power bill for the new City Hall building during the billing period of Feb 18th to March 20th was \$383.12. After all the power was cut off at the old City Hall site on February 297th, the bill was \$620,87.

October, 2018 Carrabelle was awarded a \$50k FRDAP grant for improvements to Tillie Miller Park. I have requested Courtney to secure a notice of

commencement from Fred Fox so we can begin work on that project.

John Lee and Dustin attended advanced maintenance of traffic training and are now certified.

The new online timeclocks are up and running at City Hall, the W&S dept, and the Sts & Rds dept. All employees are using the new timeclocks. CRA meeting on April 16th at 1:30.

### **STAFF REPORTS:**

City Attorney: Little Custom Homes wired \$12,000 required deposit Concerns by citizens about R-5 & C-1 allowing mobile homes Commissioner Allen motions to place on P&Z agenda for review and recommendations, Commissioner Millender seconds, all in favor, motion carried.

City Administrator: Recomends to table Item 2, W/S employee. Only had three applications, and only one showed up for an interview. Forestry set to do prescribed burn. Hangar Construction mostly complete. No word back from summer camp. All FEMA claims in @\$116,000. Time clocks working great.

City Clerk: Attended Flood training last month and advised Commission that the 10 year cumulative 50 % rule is not mandatory and many Cities were not adopting them into their flood ordinances. Recommend that the City reduce the rule in Ordanince 457.

Commissioner Allen motions to have Attorney draft amendment to current ordinance to reduce cumulative ratio to 1 year and add and additional 20% to the 50% of the property's certified assessed value, Commissioner Mathes seconds, all in favor, motion carried.
