NEW BUSINESS

ITEM 1. HOLD FIRST OF TWO PUBLIC HEARINGS ON THE TENTATIVE BUDGET AND PROPOSED MILLAGE RATE. (THE SECOND AND FINAL PUBLIC HEARING WILL BE HELD ON SEPTEMBER 29, 2020 AT 5:01 P.M. AT CARRABELLE MUNICIPAL COMPLEX). THE GENERAL PUBLIC SHALL BE ALLOWED TO SPEAK AND TO ASK QUESTIONS PRIOR TO ADOPTION OF ANY MEASURES BY THE GOVERNING BODY. THE GOVERNING BODY SHALL ADOPT ITS TENTATIVE MILLAGE RATE PRIOR TO ADOPTING ITS TENTATIVE BUDGET. PRIOR TO THE CONCLUSION OF THE HEARING, THE GOVERNING BODY OF THE TAXING AUTHORITY SHALL AMEND THE TENTATIVE BUDGET, RE-

COMPUTE ITS PROPOSED MILLAGE RATE, AND PUBLICLY ANNOUNCE THE PERCENT, IF ANY, BY WHICH THE RE-COMPUTED PROPOSED MILLAGE RATE EXCEEDS THE ROLLED-BACK RATE. THAT PERCENT SHALL BE CHARACTERIZED AS THE PERCENTAGE INCREASE IN PROPERTY TAXES TENTATIVELY ADOPTED BY THE GOVERNING BODY.


NOTE: Anyone needing action taken by the Commission needs to be placed on the agenda and all required paperwork submitted by Wednesday, 8 days prior to meeting.


