Summary Abatement. In addition to the remedies prescribed by this Ordinance, and cumulative thereof, it shall be brought to the attention of the City Commission, and it shall be determined that any such nuisance, or nuisances, are likely to have an immediate adverse effect upon the public health, comfort or safety, then and in that event the City Commission may by appropriate Resolution or motion, order such nuisance or nuisances summarily abated by the City in a reasonably prudent manner.
