HOLD AMENDED PUBLIC HEARING ON THE FINAL BUDGET AND ITEM 1. PROPOSED MILLAGE RATE. THE FIRST SUBSTANTIVE ISSUE DISCUSSED SHALL BE THE PERCENTAGE INCREASE IN MILLAGE OVER THE ROLLED-BACK RATE NECESSARY TO FUND THE BUDGET, IF ANY, AND THE SPECIFIC PURPOSED FOR WHICH AD VALOREM TAX REVENUES ARE BEING INCREASED. THE GENERAL PUBLIC SHALL BE ALLOWED TO SPEAK AND TO ASK **OUESTIONS PRIOR TO ADOPTION OF ANY MEASURES BY THE** GOVERNING BODY. THE GOVERNING BODY SHALL ADOPT ITS FINAL MILLAGE RATE PRIOR TO ADOPTING ITS FINAL BUDGET. PRIOR TO THE CONCLUSION OF THE HEARING, THE GOVERNING BODY OF THE TAXING AUTHORITY SHALL AMEND THE FINAL BUDGET, RE-COMPUTE ITS PROPOSED MILLAGE RATE, AND PUBLICLY ANNOUNCE THE PERCENT, IF ANY, BY WHICH THE RE-COMPUTED PROPOSED MILLAGE RATE EXCEEDS THE ROLLED-BACK RATE. THAT PERCENT SHALL BE CHARACTERIZED AS THE PERCENTAGE INCREASE IN PROPERTY TAXES ADOPTED BY THE GOVERNING BODY.
