Comm. Walden: Will be resigning effective November 1st to drawl retirement Would like to have the dedication of Hwy 67 to Office Patton on next months agenda.

Comm. Millender:

Mayor La Paz: Reported that during heavy rains the weekend of September 26 and 27, the WWTP hit its intake capacity at 1.1 million gallons which was due storm water infiltration pinpointed to the McKissack Beach Subdivision area. The W&S Superintendent will contract with a company who specializes in identifying the infiltration locations, and who will excavate the areas and make repairs. It will take about 5 days to complete at a cost of \$12,000 and the Sewer dept will pay for the needed parts. The property owners will be notified. Directed staff to begin requesting a written quote from all bidders for city contracted work and services, even if there is only one bid.

Request staff to remind professional tree service and land clearing company owners that they are to haul debris from their professional jobs to the landfill and not dispose of on the public rights-of-ways.

Directed staff to post all the 2020 City Meeting Minutes and the 2018 FLUM series on the City's website.

Directed staff that all City-related Meeting Minutes, including the Commission, CRA, and P&Z to include a statement at the bottom that reads: Approved by the Carrabelle City Commission, or the CRA Board, or the P&Z board, with a date line and signature lines for the Mayor and/or Chairperson which should be attested by the City Administrator.

Waterfront Partnership: FWC 2019/2020 Derelict Vessel Removal Grant Program Update from the Carrabelle Waterfront Partnership:

On September 11, Steve Cook from FWC reported continued progress on the derelict vessels as follows:

The review of the boat at Sunset Isle has been completed and the City has a removal authorization letter.

The *Anthony Diane* at the Vinay Bose' tock has progressed well and he anticipated having a removal authorization letter to the city by the end of the month.

The *Spare Time* also at the Bose' dock is still currently ongoing and he spoke with the officer working the case and urged him to finish it up as soon as possible. The officer working on the *Miss Carrabelle* will stand by until the *Anthony Diane* is removed. He thinks it would be nearly impossible to delineate what is

the *Anthony Diane* and what is the *Miss Carrabelle*. So if the contractor does a thorough job there would not be any of the *Miss Carrabelle* to remove, if there is anything still left. Also, it doesn't seem like a good use of tax dollars to hire someone to remove something we aren't even sure is still there but we can reevaluate once the *Anthony Diane* is gone.

They are also aware that there is a small sailboat anchored behind the boats at the Bose' dock.
