Mayor La Paz: On January 10th, Courtney and Mayor met with 3 representatives from The Nature Conservancy who are working on a project to identify sites where natural features can be strengthened or features created to increase protection of communities from storms and floods – such as development of stormwater facilities. Several locations inside of the City requiring of stormwater management were mapped.

The Mayor notified Mr. Solomon, TDC Executive Director, that the Carrabelle public, CRA Board members, and the City Administrator requested that the Mayor reach out to the TDC for funding for replacement of the badly worn, 15-year-old playground equipment at Sands Park. At the February 9th TDC meeting, the Mayor will alert the TDC Board that the City Administrator is assembling a funding request for replacement of 15 children's playground pieces with equivalent funding for playground equipment at a tourist-related park in Apalachicola. Explained that tourist development, its tax collections and revenues and expenditures all fall under the jurisdiction of the Franklin County Board of County Commissioners who ultimately approve or disapprove all spending and projects recommended to them by the TDC – an advisory board.
