complete the repairs. The culvert pipe is in stock and it is ready to ship. Reported the total cost for the repair is \$116,770 which will be shared equally by the City of Carrabelle and Franklin County District 5, making the final cost to each agency \$58,385. In addition to this cost, Franklin County developed the interlocal agreement and contracted with Roberts and Roberts. Carrabelle provided the site survey and our engineer provided the engineered plans.

Reported the Franklin County Commissioners will soon consider doing away with the beach flag warning system at Carrabelle Beach through a Public Hearing.

Reported that Carrabelle citizen, Mark Melcher, salvaged the old Veterans Park Wall Commemorative Bricks at the former City Hall building. He cleaned and repaired the bricks, and mounted them on the front wall of the new CGJM museum building on Hwy 98.
