The Riverfront Festival hosted by the Carrabelle Chamber of Commerce is Saturday, April 27 from 10 am - 6 pm along the Carrabelle waterfront. This event is FREE, pet friendly, and open to the public.

On March 28, I attended the ARPC board meeting and got an update on our Franklin 98 Living Shoreline Project. Phase I of the project is proceeding according to schedule, with reefs nearly built-out. Construction crews are currently engaged in cleanup activities along the shoulder of Highway 98, addressing any disturbances caused by the construction efforts. The project team is currently in the process of securing the necessary permits from the State for Phase 2 of the project. Upon issuance of the permit, construction activities for Phase 2 will commence. If you would like to learn more or keep up with the progress, the staff has developed informational materials and wepages detailing the project, and providing educational resources at arpc.org.

A couple of months ago, I reported that our waterway is having continuous issues with derilict vessels. Capt Kim from C'quarters suggested that the City contact the state about reinstating the seaplane landing strip to help elliviate vessels being anchored and abandoned in our waterway. This would also be an asset to the city. I would like to request that this be on our next regular meeting agenda to further this discussion and make a plan with the state for this potential request.
