Comm. Brown: On March 30<sup>th</sup>, I attended the March Apalachee Regional Planning Council Board Meeting in Tallahassee. I am excited to report on the Franklin-98 (F-98) Living Shoreline Resiliency Project. ARPC has successfully sourced contractors for the Franklin-98 project. Gulf Corps of the Forgotten Coast, based in Franklin County, is the contractor responsible for the planting portion of the restoration process. LiveFlyer, Inc., from Carrabelle, was selected as the contractor for the hard bottom reef materials that will be placed at the selected project sites. The installment of reef materials will take place in late spring to summer.

The Franklin County Board of County Commissioners (BOCC) has asked our State Representatives to work in this Legislative Session to modify how Franklin County can use its Tourist Development taxes. With the added visitors to our small and fiscally constrained county, comes additional stress on our resources and infrastructure. Hence the reason we need to use more of the TDC taxes for infrastructure elements. I would like to request that the City, with the Commission's support, send an email to Rep. Jason Shoaf and his aides and Senator Corey Simon and his aids. I am happy to provide all of the necessary contact info and an example email to our City Administrator if approved. Saturday, April 22<sup>nd</sup> The Carrabelle Chamber of Commerce is hosting the 32<sup>nd</sup> annual Carrabelle Riverfront Festival in downtown Carrabelle from 10am – 6pm. This is a free event full of family-friendly activities, live music, entertainment, unique arts & craft vendors, & delicious food. This year there is a kid's nautical themed costume contest. Also, the Carrabelle History Museum will be hosting their Ave B Expo featuring natural resource experts, regional history exhibits, live animals, and educational activities and displays.
