Comm. Brown: I hope everyone has had a fresh start to the new year. We have a couple of events coming up this weekend.

Friday is our February First Friday downtown. The local businesses will be open late with live music, after-hours shopping, refreshments, gorgeous art, & delicious food

Saturday is the 2nd annual Crooked River Park Fest from 9 am - 9 pm. The all-day festival features a Country 'Super' Market from 9 am - 5 pm, followed by Crooked River Park Fest Benefit Concert from 6 pm – 9 pm. Capt. Kim from C-Quarters has reported that Officer Sizemore (FWC) said they are diligently working to remove the 2 eyesore boats in the river in front of C-Q. She suggested returning the opposite side of the river to a seaplane landing strip like it used to be, so the boats couldn't anchor there. This would keep derelict dangers out of the Carrabelle River. I have forwarded Capt. Kim's original email to our City Admin for further discussion.

Mayor La Paz: The Mayor reminded everyone of the Ribbon Cutting for the new Military Service Flag Memorial at Veterans Park on March 8, 2024 at 9:30 a.m. and that an announcement will be circulated.

The Mayor reported on her attendance at the Florida League of Mayors events at the Capitol held in conjunction with the League of Cities Legislative Action Days. The Mayor participated in an on-site tour of the Apalachee Center for Behavioral Health facility in Tallahassee and participated in Florida League of Mayors quarterly Board of Directors meeting while in Tallahassee.

The Mayor reported on State House Bills and State Senate Bills that if approved will affect Florida Cities; including vacation rentals, building regulations, millage rates, homestead exemption, regulation of unsafe structures, and municipal utilities including water and sewer rates and fees. The Mayor reported the following Bills are important to pay attention to:

• HB 777 and SB 1088 propose to remove municipalities' authority to impose surcharges or higher rates to customers outside their municipal boundaries. Rates, fees, and charges would be required to be the same for customers served inside and outside the municipal boundaries.

• HB 1277 and SB 1510 would impose restrictions on the use of any utility revenues to fund general government services and would again impose restrictions on extraterritorial surcharges. These bills would specify the portion of utility revenues that could be transferred to the general fund and would be based on the rate of return established by the Public Service Commission.

The Mayor said anyone can call or write our State Representatives to express concerns.
