Mayor La Paz: Reported on the new golf cart House Bill 949 that will go into effect on July 1st. Under the bill, golf cart drivers under age 18 must be at least 15 with a learner's permit or 16 with a driver's license. Florida teens will not be able to drive golf carts without proper identification. Anyone who is 18 or older must have a valid government-issued ID to drive a golf cart. Violations will be noncriminal traffic infractions, like moving violations. Reported on Florida Statutes regarding the graduating drivers licensing laws that include supervised driving and nighttime driving restrictions for ages 15 through 17. Reported the Commission will need to amend the City's Golf Cart Ordinance and until that happens, the new Florida law will supersede the City's ordinance after July 1st.

Reported the City Administrator and Mayor attended the first annual SUNS meeting on April 15th. The program was developed and implemented after Hurricane Michael, by The Nature Conservancy, US Naval Academy, the Northwest Florida Water Management District, and the St Andrews and St Joseph Bay Estuary Program along with 27 representatives from local governments and other agencies. They have developed a portfolio of 72 nature-based solution projects, 11 plans and assessments, and 5 parks and trails connector projects. During the meeting, the SUNS executive director announced they have enough funding for approximately 6 additional projects and the proposal for a public use stormwater park connected to the city's NW 1st St – NW Ave B stormwater management system will be considered as additional project for technical and financial support. Courtney has spoken with the property owner who is interested in selling the property for development of a stormwater park. Mr. Daryl Boudreau of the NWFWMD is our SUNS liaison and he will keep us updated.

Reported that property owners along the most northern block NW 4th Street contacted the Mayor, requesting intersection of NW 4th St and NW Ave G be developed into a standard 90-degree corner. This roadway has always been a sand trail through the woods, but over the past couple of years the area has developed with several new homes and limerock road base has been placed on the

make-shift roadway. The current roadway curves onto private property with little to no right of way in some areas. Reported the city has a survey of NW Ave G and the developer's survey of NW 4th St. The Mayor has reached out to the District 5 County Commissioner requesting county assistance and to share in the cost with development of a standard 90-degree corner to merge these two roadways and get NW 4th St off private property. The District 5 Commissioner will look at the location with the County Roads Dept Superintendent and follow up with me. The Mayor will keep the Commission posted on the progress.
